**ASSUMPTION OF RISK AND RELEASE OF LIABILITY ("ASSUMPTION AND RELEASE")
FOR PARTICIPATION IN FUTURE CHAMPIONS RINGETTE CAMP OPERATED BY THE PEOPLE COACH INC.**

OVERVIEW

Future Champions ringette camp is operated by The People Coach Inc., a private company operated in Sherwood Park, Alberta providing ringette training for athletes and coaches of all ages. The 2021 ringette camp is one ice time and one off ice time five days (August 16-20, 2021). The People Coach Inc. is insured through Special Risk Insurance for sport injury only. This insurance policy does not cover a pandemic (COVID-19). Each participant as well as parent / guardian assumes the health and economic risk of COVID-19.

VOLUNTARY ASSUMPTION OF RISK AND ACKNOWLEDGMENT OF RESPONSIBILITY:

1. I hereby acknowledge that there are significant risks associated with my participation and the participation of my minor child as a player ("Player") in the Future Champions Ringette Camp. This includes but is not limited to all manner of loss, injury, damage, death, expense, inconvenience or denial of opportunity arising from or related to one or more of the following:
 - a. Actual or potential infection or transmission of virus that causes COVID-19 ("Virus");
 - b. Testing, quarantine or self-isolation, as indicated or required by public health guidelines or one or more of the Organizers;
 - c. Temporary or permanent suspension or shutdown of the ringette camp due to an outbreak, case, suspected case or public health measure related to the Virus;
